



Greg Rummel Risk Management Scholarship APPLICATION FORM

The Rummel Family seeks to empower local students to excel in careers in risk management.

We are pleased to invite graduating high school seniors and students currently enrolled in college who are seeking living-wage opportunities in the field of risk management (e.g., insurance underwriting, sales agents, claims, risk managers and safety engineers, etc.) to apply for a Greg Rummel Risk Management (GRRM) Scholarship. A minimum of one scholarship will be awarded annually. Previous winners of the GRRM scholarship are eligible to reapply in following years but must meet/complete all requirements listed below each year to qualify for consideration.

To be considered for a scholarship, a student must meet the following criteria:

1. Must be a high school senior residing in Saginaw or Tuscola County and currently enrolled in a public or private high school physically located within Saginaw or Tuscola County OR a graduate from a Saginaw or Tuscola County high school who is currently enrolled in college and still has a primary home address located within Saginaw or Tuscola County.
2. Must have intent to pursue a career in risk management as demonstrated by course of study (general college prep for HS seniors or appropriate business classes for college students)
3. Must fully complete the personal information section below.
4. Must compile and submit, ***in one PDF document***, the required scholarship packet as described on the following page.
5. Must mail or e-mail fully completed scholarship packet to the address on the following page by March 25th

Scholarship(s) will be awarded on the/ basis of the applicant letter, overall application quality, scholastic performance, community service activities, and letters of recommendation.

Instructions for Scholarship Packet Submission:

1. **Complete Scholarship Cover Sheet Information Page** (previous page)
2. **Compose personal letter**
 - a. Compose a letter to the GRRM scholarship committee describing your career and educational goals and how you intend to reach those goals, including the specific risk management profession you wish to pursue and why. Finally, tell us how you aspire to utilize one of the Rummel core values from the below list while learning or practicing your intended risk management profession:
 - i. Honesty
 - ii. Integrity
 - iii. Learning, Developing & Growing
 - iv. People & Relationships Matter
 - v. Professionalism

Technical Requirements for the Essay:

300-500 words, typed

3. **Letters of Recommendation**

Please provide two letters of recommendation from teachers, counselors, volunteer leaders or a work supervisor who can describe your abilities and potential to pursue a career in risk management **or** how you have exemplified one of the Rummel core values above.
4. **Activity Sheet**

List the activities and community services that you have been involved with in the last 4 years.
5. **School Transcript**

Please include the most recent copy of your school transcript, showing a **cumulative GPA of 3.0 or higher**. Screen shot from your school's website, showing name of school, your name, and cumulative GPA is acceptable.
6. **E-mail or mail your scholarship packet by March 25**
